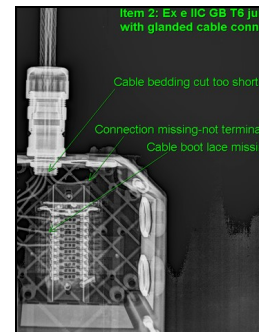

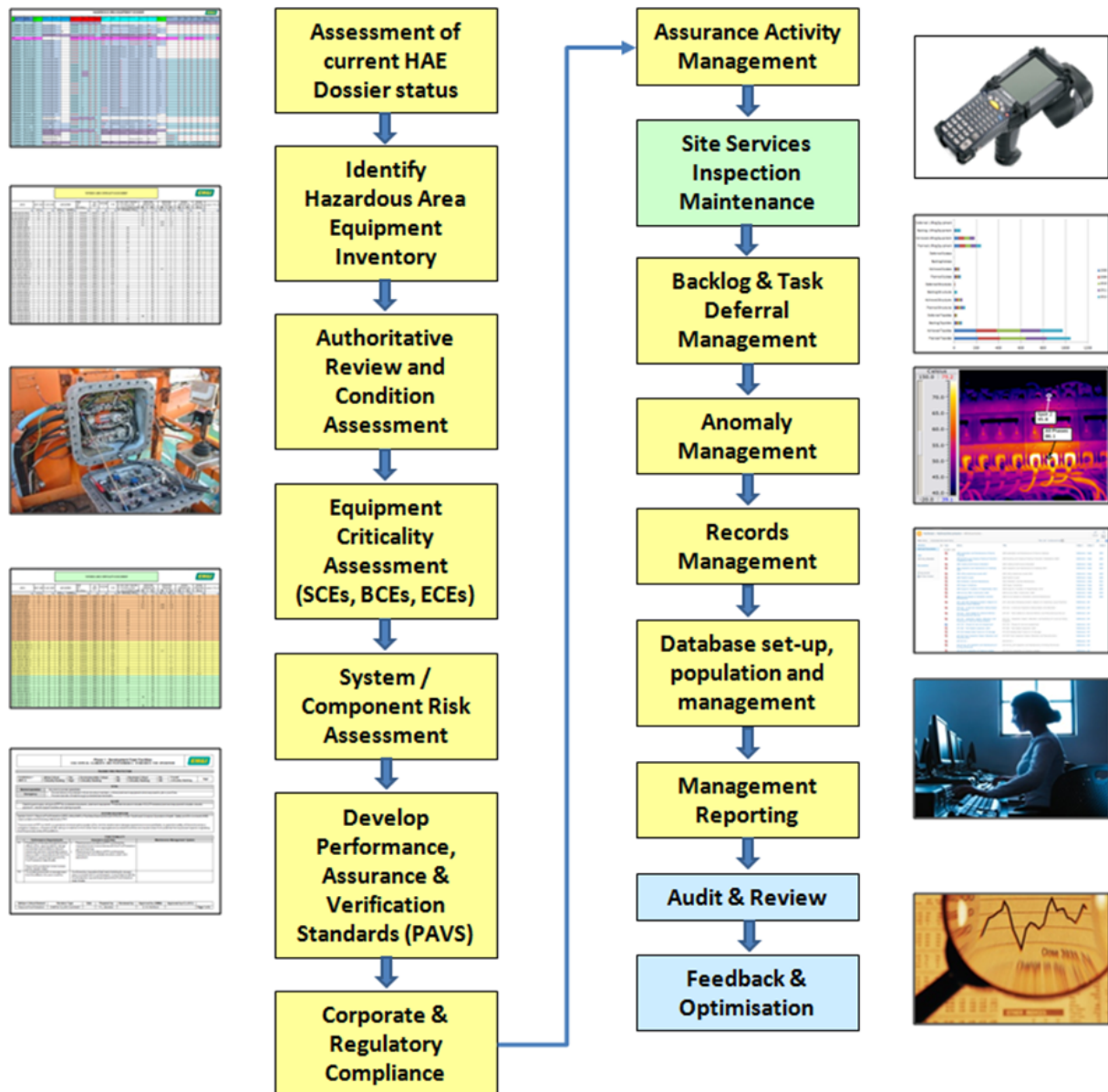
Compliance – EM&I's methods are approved by Classification Societies and accepted by regulators worldwide.
